INTRODUCTION

Information We Collect and How We Collect It

We collect information from and about users of our Application:

- · Directly from you when you provide it to us.
- Automatically when you use the Application.

Information You Provide to Us

When you download, access and use this Application, we may ask you to provide information by which you may be personally identified, such as name, email address, telephone number or any other identifier by which you may be contacted online or offline ("personal information").

Automatic Information Collection

When you download, access and use the Application, it may use technology to automatically collect:

Usage details. We may automatically collect certain details of your access to and use of the Application, including communication data and the resources that you access and use on or through the Application.

- To fulfill the purpose for which you provide it. For example, if you give us an email address to use the feedback feature of our Application, we will transmit the contents of that email and your email address to the recipients.
- For any other purpose disclosed by us when you provide the information.
